Application Fee - \$55 per application, non-refundable, once off payment, pay when submit the application.

Capital Levy - \$50 per family per term.

College Fees are all inclusive of all levies - This includes swimming, the College laptop scheme, music, camps, excursions and incursions and publications including school diary and yearbook.

Sibling discounts are applied on College Fees if there are two or more students of one family attending the College concurrently.

Payment Arrangements – College fees will be invoiced at the beginning of each term. Fees are due and payable in full on the Friday of the second week of each term unless a direct debit arrangement is in place.

Paying Your Fees – Wisdom College has partnered with specialist provider Edstart to make managing your school fee payments easier. Through Edstart Plus, the school is able to provide flexible payment options to all families for the payment of school fees:

- Pay weekly, fortnightly, monthly, termly or annually by selecting the schedule that works best for you
- Ability to pay via direct debit, debit/credit card of BPay

To pay your school fees, please set up your account via the link that has been emailed to you or contact Edstart on 1300 139 445 for assistance.

Please Note:

1. **College Fees** DO NOT cover, uniforms, or students owned books, stationery and laptop repairs.
2. **There may be additional charges** made for the year if the student chooses to study subjects such as Visual Art for which the materials/consumables are costly. This information will be provided at the time of subject selection.
3. **Private lessons** may be made available throughout a school year in activities such as Music and Speech & Drama. Payments for these lesson are arranged directly with the Tutor.
4. **Participation** in some of the co-curricular activities also attracts a fee. These fees vary depending upon the activity, with registration and payment completed per activity via the School’s electronic payment system.
5. **Student withdrawals:** Where a parent or guardian wishes to withdraw a student from the College: For the current school term: the term college fee will be charged. For the following school term: no additional fee will be charged if the College is informed before the current school term finishes.
6. **Bad Debt Policy:** Legal action will be taken to recover any outstanding fees including lapsing of direct debit payments followed by placing the debt with a collection agency and listing a family account as default credit.

As Edstart's payment service is regulated by ASIC, we are required by law to verify your identity before setting up your account by cross-referencing the details on your credit report. This will not impact your credit file or your credit rating. Alternatively, you can provide your Driver Licence or Passport to complete this process.
